Authorities

The lawyers of the Company "OL&RUST" grant the Clients the full service range concerning communication with authorities. The process is not limited on the presenting the Client's interests during the inspections, it upmost supposes definite preventive measures to avoid any possible disputable and conflict situations with the authorities. For that purpose the Company's counsellors regularly advise the Client about organisation of the business-processes in compliance with the Ukrainian legislation. Among the considerable preventive methods there is applying of the training practice for the Client's staff as to coordinated actions with public authorities and local self-government.

Judicial practice

Our attorneys have appeared before local general courts, economic courts, administrative district courts, appellate courts, the High Economic Court of Ukraine, the High Administrative Court of Ukraine, and the Supreme Court of Ukraine. Our lawyers take part in cases on bankruptcy, debt collection, invalidation of public authorities' acts, acknowledgement of title to real estate and land, labour disputes, unfair competition, abrogation of tax notifications and decisions. Moreover, the group lawyers have considerable experience in granting legal aid and settling Client disputes in arbitration, including conflict resolution, compiling arbitration clauses and representing interests in arbitration.

In connection with coming into force of the Law of Ukraine «About joint-stock companies» for many subjects of business operating in organizational-legal form Joint-stock company, there is an urgent necessity for reduction of their structure for conformity with the new requirements. With this purpose the experts of “OL&RUST” developed a unique methodology on adaptation the organizational and legal structure to the new realities. The renewed structure includes as actually preparation and registration of a new edition of the charter, support of registration of issue of actions to the State Commission on Securities and Stock Market, creation and introduction of local statutory acts in consideration of the corporate culture principles, and the organization and carrying out of the general meetings, sessions of the supervisory council, etc.
